

# **Digital Millennium Copyright Act**

#### **DIGITAL MILLENNIUM COPYRIGHT ACT**

LAST UPDATED: December 21, 2022

www.stewartbrownjr.com respects copyright owners. If you ("Complainant") believe that your work has been copied in a way that constitutes copyright infringement by www.stewartbrownjr.com, please provide to www.stewartbrownjr.com copyright agent the information listed below. To be considered effective pursuant to the Digital Millennium Copyright Act ("DMCA"), 17 U.S.C. § 512(c)(3), your notification must include the requested information below. This procedure is exclusively for notifying www.stewartbrownjr.com that your copyrighted material has been infringed:

- An electronic or physical signature of the person legally authorized to act on behalf of the owner of the copyright interest.
- A description of the copyrighted work that you claim has been infringed.
- A description of where the material that you claim infringes your copyright is located on the site.
- Your address, telephone number and e-mail address.
- A statement by you that you have in good faith believe that the disputed use is not authorized by the copyright owner, its agent, or the law.
- A statement by you, made under penalty of perjury, that the above information in your notice is accurate, and that you are the copyright owner or legally authorized to act on behalf of the copyright owner.
- Designation Of Agent To Receive Notification Of Claimed Infringement.

Upon receipt of notification of claimed copyright infringement, www.stewartbrownjr.com will follow the procedures outlined in the DMCA.

## **Notice And Take-Down Procedures**

If www.stewartbrownjr.com is notified of a credible claim of copyright infringement, or otherwise becomes aware of facts and circumstances from which infringement is apparent, it will respond expeditiously by removing, or disabling access to, the material that is potentially infringing pursuant to the DMCA.

### **Counter Notification**

If you receive a DMCA notification and believe, upon good faith, that the content was removed or disabled in error, you may provide a counter-notice by notifying us in writing at the designated agent address above, or by emailing stewartbrownjr1@gmail.com, and providing the following information:

- A physical or electronic signature (type your full name).
- Identification of the material that has been removed or to which access has been disabled and the location at which the material appeared before it was removed or access to it was disabled.
- A statement under penalty of perjury that you have a good faith belief that the material was removed or disabled as a result

of mistake or misidentification of the material to be removed or disabled.

- Your name, mailing address, and telephone number, and a statement that you consent to the jurisdiction of the federal district court for the judicial district in which your address is located, or if your address is outside of the U.S., for any judicial district in which www.stewartbrownjr.com may be found, and that you will accept service of process from the Complainant who provided the copyright notification or an agent of such Complainant.

Upon receipt of a counter-notice, www.stewartbrownjr.com shall promptly forward a copy to the Complainant and inform Complainant that it will replace the removed material or cease disabling access to it in ten (10) business days. www.stewartbrownjr.com may replace the removed material and cease disabling access to it in not less than ten (10) business days and no more than fourteen (14), business days following receipt of the counter-notice unless www.stewartbrownjr.com first receives notice from Complainant that it has filed an action seeking a court order to restrain the www.stewartbrownjr.com customer from engaging in infringing activity relating to the material on www.stewartbrownjr.com web hosting site.

Please note and understand before submitting a counter-notice: Under Section 512(f) of the DMCA, any person who knowingly materially misrepresents that material or activity was removed or disabled by mistake or misidentification may be subject to liability.

#### **Accommodation Of Standard Technical Measures**
